With this transmittal, Verizon hereby submits tariff pages to make the following revisions:

- Under Tariff F.C.C. No. 1, Verizon is introducing the Commitment Discount Plan (CDP), which provides for the application of discounted monthly rates for services included in the Plan based on a minimum commitment level of channel terminations.

- Under Tariff F.C.C. No. 11, Verizon is modifying the existing CDP offering to add IntelliLight[®] Entrance Facility (IEF) services as an optional service type, and change any associated regulations, as appropriate, to reflect the introduction of the new option.
- Under authority of Special Permission No. 04-042 of the Federal Communications Commission, Verizon is introducing an option for CDP that, under certain conditions, allows a customer to establish a coterminous expiration date for its plans in both Tariff F.C.C. Nos. 1 and 11.

Supporting material as specified under Section 61.49 of the Commission's Rules is not required with this filing. However, a document is attached that describes in detail the tariff revisions included in this transmittal.
