With this transmittal, Verizon is submitting tariff pages to introduce the following:

1. Contract Tariff Option No. 11 in Tariff F.C.C. No. 1 and Contract Tariff Option No. 14 in Tariff F.C.C. No. 11. These Contract Tariffs are exclusively for new installations of IntelliLight[®] Optical Transport Service (IOTS) ordered during a specific period of time in specified Metropolitan Statistical Areas (MSAs).

2. Contract Tariff Option No. 12 in Tariff F.C.C. No. 1 and Contract Tariff Option No. 15 in Tariff F.C.C. No. 11. These Contract Tariffs are exclusively for new installations of IntelliLight Dedicated SONET Ring (IDSR) service ordered during a specific period of time in specified MSAs.
3. Contract Tariff Option No. 14 in Tariff F.C.C. No. 1 and Contract Tariff Option No. 16 in Tariff F.C.C. No. 11. These Contract Tariffs are exclusively for new installations of DS1 and DS3 service ordered during a specific period of time in the New York New and Jersey Corridor portion of the New York-NY MSA.
4. Contract Tariff Option No. 15 in Tariff F.C.C. No. 1. This Contract Tariff is exclusively for dual installations of new Special Access IntelliLight[®] Dedicated SONET Rings with enhanced nodes ordered during a specific period of time in specified MSAs.

Support material as specified under Section 61.49 and 61.55 of the Commissions Rules is not required with this filing. However, a document describing the new contract options is attached.
