Under authority of Special Permission No. 04-043 of the Federal Communications Commission, Verizon is introducing a new Contract Tariff Option in its Tariff F.C.C. Nos. 1 and 11, (Option 16 in Tariff F.C.C No. 1 and Option 17 in Tariff F.C.C. No. 11). This Contract Tariff Option is an offering exclusively for customers subscribing to a minimum of fifteen new IntelliLight® Entrance Facility (IEF) systems with each system configured to include a Fractional OC48 Interface and twelve or more STS1 terminations.

Supporting material as specified under Section 61.49 of the Commission's Rules is not required with this filing. However, a document is attached that describes in detail the tariff revisions included in this transmittal.
