Dear Secretary:

The accompanying tariff material, issued by Citizens Telecommunications Companies ("Citizens") and scheduled to become effective July 1, 2004, is sent to you for filing in compliance with the Communications Act of 1934, as amended. With this filing, Citizens corrects an error made in Transmittal No. 151, under authority of Special Permission No. 04-049.

On June 16, 2004 Citizens made its annual access tariff filing under Transmittal No. 151, which is scheduled to become effective on July 1, 2004. After Transmittal No. 151 was filed, an error was discovered on 23rd Revised Page 820. The page filed included a change to the Multi-line Business End User Common Line rate, when this rate should not have been changed. Support material filed with Transmittal No. 151, including the relevant Tariff Review Plan, correctly indicates that this rate does not change. Citizens sought and obtained waiver of \$61.58 and \$61.59 to correct this error while retaining the July 1, 2004 effective date.

In accordance with the Commission's fee filing requirements, the original of this Transmittal (without revised tariff material), together with a completed FCC Form 159 and a check payable to the Federal Communications Commission in the amount of six hundred ninety five dollars (\$695.00), has been forwarded to the designated office of the Mellon Bank in Pittsburgh, Pennsylvania.
