The issuing carriers for JSI Tariff F.C.C. No. 1 are listed on the attached page, with indication of each issuing carrier's respective FRN.

In addition to the annual filing for carriers filing under Section 61.38, this filing includes a midcourse filing for Pineland Telephone Cooperative, Inc., who files under Section 61.39. The proposed revisions for Pineland represent reductions in rates for Asymmetrical Digital Subscriber Line (ADSL) Service. The midcourse filing is necessary because increases in demand over the past year for Pineland ADSL Service have significantly decreased the cost per line.

Pursuant to Section 61.38 of the Commission's Rules, cost support information is being furnished for the issuing carriers indicated on Appendix A filing pursuant to Section 61.38. The accompanying cost support includes the Tariff Review Plan schedules required for rate-of-return carriers prescribed by the *2004 TRP Order* as modified by the *2004 TRP Errata*.

Pursuant to Section 61.39 of the Commission's Rules, cost support for Pineland Telephone Cooperative, Inc. is available upon reasonable request by the Commission or interested parties.
