Pursuant to Special Permission No. 04-053, this filing proposes revisions, prior to having been in effect for 30 days, to rates filed by JSI on behalf Hargray in Transmittal No. 96 on June 16, 2004. Hargray files its tariff pursuant to Section 61.38 of the Commission's rules.

Pursuant to Special Permission No. 04-053, the proposed effective date for the revisions filed under this transmittal is July 1, 2004 on less than fifteen days or seven days notice, respectively for rate increases or reductions, as the case may be. Specifically, the filing serves to reduce on an overall basis the rates for Special Access and Local Transport filed on June 16, 2004 to reduce the projected annual revenues for Special Access recovered from interexchange carriers by \$300,000 as explained in JSI Application No. 18 filed with the Commission on June 29, 2004 and also in the accompanying description and justification.
