With this filing Ameritech is proposing to grandfather the Optional Calling Plan in it's Tariff F.C.C. No. 4, Enhanced Ameritech ValueLink Plus Service. Enhanced Ameritech ValueLink Plus Service will no longer be available to new customers effective July 2, 2004. There will be no change in service to existing customers. Existing customers currently on a term plan can remain until their term expires. Renewals will no longer be available. Existing customers on a month-to-month plan can remain until they move or voluntarily cancel their plan.

The changes do not effect price cap indices. Customers have been notified through a bill page message.
