The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Section 61.58 and 61.59 of the Commission's Rules.

On July 2, 2004, Verizon filed Transmittal No. 465, which removed the tariff references for Digital Subscriber Line (DSL) service that limit the availability of DSL to lines over which line sharing is available. Transmittal No. 465 also changed references to "facilities" rather than "copper facilities" in its DSL regulations. Transmittal No. 465 is scheduled to become effective July 17, 2004. Based on discussions with the Commission staff, Verizon wishes to withdraw the tariff material filed under Transmittal No. 465 and reinstate material presently in effect.

A waiver of Section 61.59 is necessary in order to make changes to material not yet in effect and a waiver of Section 61.58 is necessary to file on less than statutory notice.

This application and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).

Payment in the amount of \$695.00 has been electronically transmitted to the Mellon Bank in Pittsburgh, Pennsylvania, in accordance with the fee program procedures. The Form 159 is being transmitted electronically via ETFS.
