This filing is being made on 15 days' notice under the Commission's streamlined filing procedures, and proposes the following revisions to Tariff F.C.C. No. 3:

- 1) Tariff language revisions to Sprint LTC's term discount plan provisions to clarify that in addition to eligible circuits, including those with company provided channel terminations and multiplexers, they also include circuits for which the Telephone Company provides only some other portion of the circuit, such as interoffice mileage;
- 2) Addition of tariff language identifying DSL wire centers in Virginia Regions 1 and 2; and
- 3) Minor tariff language changes designed to clarify the provision of interstate access services.


