The accompanying tariff material, issued by the Verizon Telephone Companies (Verizon) and bearing Tariff F.C.C. No. 1, Access Service, and Tariff F.C.C. On July 2, 2004, Verizon filed Transmittal No. 465, which removed the tariff references for Digital Subscriber Line (DSL) service that limit the availability of DSL to lines over which line sharing is available. Transmittal No. 465 also changed references to "facilities" rather than "copper facilities" in its DSL regulations. Based on discussions with the Commission staff, and under authority of Special Permission No. 04-056, Verizon is withdrawing the tariff material filed under Transmittal No. 465 and reinstating material presently in effect.

Supporting material as specified under Sections 61.49 of the Commissions Rules is not required with this filing.
