This filing is being made by Qwest in its Tariff F.C.C. No. 1, Section 5, Ordering Options for Access Services, to revise the Expedite Order Charge application to a per day charge structure. Supporting information discussed under Section 61.38 or 61.49 of the Commission's Rules is included in the attached Description and Justification (D&J).

In Section 8, Advanced Communications Networks, Qwest is introducing a promotion for ATM, Local Area Network (LAN) Switching Service (LSS) and Frame Relay Service (FRS). Under the terms of this promotion, Qwest will waive the nonrecurring charges for customers who purchase ATM, FRS and LSS with term plans of 36-months or greater. This promotion will be in effect from July 31, 2004 through October 31, 2004.

Qwest is offering this promotion to stimulate demand. As a result of this promotion Qwest estimates that demand for these Services will increase as follows: 24 ATM Services, 1,254 Frame Relay Services and 3 LSS Services. Qwest expects a total increase in revenue of approximately \$4,986,000 for the first twelve months.

Qwest is also implementing a promotion for *Qwest Choice DSL*, *Qwest Choice DSL Deluxe* and Stand Alone *Qwest DSL*. Under the terms of this promotion, the Nonrecurring Charge for these services will be reduced to \$9.99. In addition, the Monthly Recurring Charge for *Qwest Choice DSL Deluxe* will be reduced to 26.99 for the first three months of service. This promotion is scheduled to run from July 31, 2004 to October 22, 2004.

Qwest is offering this promotion to stimulate demand for its DSL Products. As a result of this extension, Qwest estimates that demand for DSL services will increase as follows: 818 *Qwest Choice DSL*, 769 *Qwest Choice DSL Deluxe* and 49 Stand Alone *Qwest DSL*. Qwest expects a total increase in revenue of approximately \$505,333 annualized.

Supporting information discussed under Sections 61.38 and 61.49 of the Commission's Rules is, to the extent required, included in this transmittal letter.

In Tariff F.C.C. No. 2, Special Construction, Qwest is also adding seven new special construction cases in section 6 of the tariff.

Supporting information discussed under Section 61.38 of the Commission's Rules is included in the attached Description and Justification (D&J).

The Tariff filing fee in the amount of \$695.00 is being paid by credit card through the appropriate entries in Section E of the ETFS generated Form 159.
