5.2 ACCESS ORDER

5.2.2 ACCESS ORDER MODIFICATIONS (Cont'd)

D. Expedited Order Charge

When placing an Access order for service(s) for which standard intervals exist, a customer may request a service date that is prior to the standard interval service date. A customer may also request an earlier service date on a pending standard or negotiated interval Access Order. If the Company agrees to provide the service on an expedited basis, an Expedited Order Charge will apply.

A customer may request a change of end user premises within the same serving wire center. When this occurs, the service date is changed to reflect the standard interval. If the customer requests an earlier service date, an Expedited Order Charge will apply.

Expedited Order Charges will not apply if the revised interval to a pending order is equal to or longer than the standard interval for that service.

Expedited Order Charges will not apply to part-time audio, part-time video or *QWEST DSL* Service.

When an expedited service date is missed, the Expedited Order Charge will apply unless the missed service date is caused by the Company.

The Expedited Order Charge will apply to all products and services found in this tariff unless otherwise specified. This charge will be applied when the customer requests a service date that is prior to the standard interval service date on an Access Order or when a customer requests an earlier service date on a pending standard or negotiated interval Access Order.

A5. ATM, FRS and LSS Pricing Plan Promotion – July 31, 2004 through October 31, 2004.

For a limited time only, from July 31, 2004 through October 31, 2004, all nonrecurring charges for ATM, FRS and LSS will be waived as set forth, following. This promotion is available to:

- New customers subscribing to a new 36-month or greater Fixed Period Service Rate Plan and existing customers signing a contract renewal for a 36-month or greater Fixed Period Service Rate Plan
- Existing customers who have a 36-month or greater Fixed Period Service Rate Plan with at least 13 months remaining on the plan can add new locations
- Existing customers who have a 36-month or greater Fixed Period Service Rate Plan with at least 13 months remaining on the plan who upgrade existing Access Links and/or ports/speeds to a higher capacity service as follows:
 - FRS customer upgrading to a higher speed FRS, ATM or LSS
 - LSS customer upgrading to a higher speed LSS or ATM
 - ATM customer upgrading to a higher speed ATM
 - TLS customer migrating to LSS

Should this service be disconnected prior to completion of the Fixed Period Service Rate Plan, the customer would forfeit the nonrecurring waiver and be subject to the Termination Liability and Waiver Policy. This offering is not available with other promotions, and does not apply to Special Construction Charges. Available only where facilities exist.

Signed Service Agreements must be submitted on or before October 31, 2004 with order applications into the system by November 29, 2004. Order completion for FRS – DS1 and below must be within 90 days of the order application date and for FRS – DS3 and ATM must be within 120 days of the order application date. When order completion is delayed due to Company reasons, the order completion date will be extended.

For a limited time only, the nonrecurring charge for *Qwest Choice DSL, Qwest Choice DSL Deluxe* and *Stand Alone Qwest DSL* will be \$9.99 for customers who apply for new service. For customers ordering new *Qwest Choice DSL Deluxe* or upgrading from *Qwest Choice DSL* to *Qwest Choice DSL Deluxe*, the monthly recurring rate will be reduced to \$26.99 for the first 3 months the *Qwest Choice DSL Deluxe* is in service after the initial 3 months the monthly rate will revert back to the current rate of \$28.00. The Speed/Destination Channel Change Charge will be waived when:

- Upgrading from *Qwest Choice DSL* to *Qwest Choice DSL Deluxe*
- Changing from *Stand Alone Qwest DSL* to either *Qwest Choice DSL Deluxe* or any *QWEST DSL PRO* Service
- Upgrading from *Qwest DSL 640k* to *Qwest Choice DSL Deluxe*
- Upgrading from either *Qwest Choice DSL* or *Qwest Choice DSL Deluxe* to any *QWEST DSL PRO* Service

Customers must apply for service from July 31, 2004 through October 22, 2004 to be eligible for the promotion, with order completion within 60 days of the order application date. When order completion is delayed due to Company reasons, the order completion date will be extended. This offering is not available with any other promotion and is not available as part of the *QWEST DSL* Volume Plans.
