Provision of Unprotected OC192 Optical Transport Channel service in LATA 236 as an extension of Washington Interagency Telecommunications System 2001 (WITS 2001) as set forth in Section 10.9.5 preceding. These Unprotected OC192 Optical Transport Channels are for the exclusive use of the U. S. Department of Defense and are not available in any other LATA or to any other branch of the Federal Government. The service is being provided for a term of five (5) years. Termination liability as set forth in Section 7.2.14(C)(4)(e) preceding applies in the event that service is discontinued prior to the end of the 5 year term. At the end of the 5 year term, the customer may discontinue service or continue with the service on a month-to-month basis at the rates and charges set forth below.

The monthly rate for each Unprotected OC192 Transport Channel service applies as a single recurring rate for the entire end-to-end channel, regardless of the underlying protocol being transmitted.

A nonrecurring installation charge applies for each Unprotected OC192 Transport Channel service installed. An initial installation nonrecurring charge applies for each channel installed in conjunction with initial delivery of the service to the customer. Each channels installed subsequent to the initial delivery of service is subject to a subsequent installation nonrecurring charge.
