In this filing, JSI proposes modification of JSI Tariff FCC No. 1 to introduce Local Number Portability ("LNP") End User Service for Coastal Utilities, Inc. ("Coastal"), an issuing carrier for JSI Tariff FCC No. 1.

Attendant to introduction of LNP End User Service for Coastal, JSI proposes moving regulations for LNP End User Service and LNP Query Service from Section 6, Switched Access, to Section 13, Miscellaneous Service. JSI originally filed regulations for LNP in 1999 under the title "Service Provider Number Portability." Subsequent to JSI's filing in 1999, the National Exchange Carrier Association ("NECA") introduced LNP services and placed them in Section 13, Miscellaneous Service of NECA Tariff FCC No. 5. As LNP Services are not a switched access service, JSI believes it is appropriate to move the regulations to new Section 13.15 under the title "Local Number Portability." In addition to moving the regulations, JSI is revising the text to align it with text in Section 13.14 of National Exchange Carrier Association (NECA) Tariff FCC No. 5. The changes to effect alignment with NECA Tariff FCC No. 5 do not affect the manner of application of charges or alter the regulations other than for expansion to intermodal LNP.

Additionally, JSI proposes, on behalf of Concord Telephone Company ("CTC") and Smart City Telecom ("SCT") to move their respective Service Provider Number Portability rates, without change, from their respective Section 17.2.2 Switched Access Local Transport rate sections to their respective Section 17.4.4 Miscellaneous Service rate sections together with replacing the term "Service Provider Number Portability" with "Local Number Portability."

Finally, because CTC's LNP End User charge expired in March of 2004, JSI proposes removing those rates from Section 17.2.2 without replacement at Section 17.4.4. Thereby only CTC's LNP Query Service rates appear in the proposed revised page for CTC's LNP Service rates.

Pursuant to Section 61.38 of the Commission's Rules, JSI is providing a Description and Justification and cost support for this filing on behalf of Coastal.

Pursuant to Section 61.32(b) of the Commission's Rules, the original of this letter, Form 159, and a check for \$720.00 have been sent via overnight delivery to the Mellon Bank, Pittsburgh, Pennsylvania, as of this date.

Customers will be notified of the proposed changes in accordance with the Commission's requirements.
