This Sprint Custom Access Solutions<sup>SM</sup> promotion waives the first month's recurring charges, as set forth in 8.7.5 preceding, when a customer installs a new Sprint Custom Access Solutions<sup>SM</sup> arrangement under a one, two or three year minimum service period. In addition, the customer will receive a credit equal to one month's recurring charges on the anniversary date of the installation of the arrangement for the duration of the minimum service period.

In the event the customer terminates its Sprint Custom Access Solutions<sup>SM</sup> arrangement prior to the expiration date of the minimum service period, any monthly recurring charges waived or credited under this promotion will be included in the calculation of the customer's termination liability charges as set forth in 8.7.2(A) preceding.

The promotion will begin on June 5, 2004, and will apply to all new Sprint Custom Access Solutions<sup>SM</sup> orders through November 30, 2004.
