**8.1.8 PROMOTIONS (CONT'D)**

- A6. *Qwest Choice DSL, Qwest Choice DSL Deluxe and Stand Alone Qwest DSL Promotion – July 31, 2004 through January 8, 2005* (C)

For a limited time only, the nonrecurring charge for *Qwest Choice DSL, Qwest Choice DSL Deluxe* and *Stand Alone Qwest DSL* will be \$9.99 for customers who apply for new service. For customers ordering new *Qwest Choice DSL Deluxe* or upgrading from *Qwest Choice DSL* to *Qwest Choice DSL Deluxe*, the monthly recurring rate will be reduced to \$26.99 for the first 3 months the *Qwest Choice DSL Deluxe* is in service after the initial 3 months the monthly rate will revert back to the current rate of \$28.00. The Speed/Destination Channel Change Charge will be waived when:

- Upgrading from *Qwest Choice DSL* to *Qwest Choice DSL Deluxe*
- Changing from *Stand Alone Qwest DSL* to either *Qwest Choice DSL Deluxe* or any *QWEST DSL PRO* Service
- Upgrading from *Qwest DSL 640k* to *Qwest Choice DSL Deluxe*
- Upgrading from either *Qwest Choice DSL* or *Qwest Choice DSL Deluxe* to any *QWEST DSL PRO* Service

Customers must apply for service from July 31, 2004 through January 8, 2005 to be eligible for the promotion, with order completion within 60 days of the order application date. When order completion is delayed due to Company reasons, the order completion date will be extended. This offering is not available with any other promotion and is not available as part of the *QWEST DSL* Volume Plans. (C)

**A. QWEST DSL HOST Service**

In the event a *QWEST DSL HOST* customer is being terminated or is exiting the business, the Company reserves the right to contact the affected *QWEST DSL* Service subscribers to determine a replacement *QWEST DSL HOST* to ensure uninterrupted service.

**B. Obligations of the Customer**

1. When a customer orders *QWEST DSL* Service, the customer must provide compatible customer premises equipment (CPE). In addition, the customer must specify the Company-provided local exchange Telecommunications Number (TN) or service address to be used. A Telecommunications Number is not required with Stand Alone *Qwest DSL*.
2. When a customer orders *QWEST DSL HOST* Service, the customer must provide the necessary information (e.g., Data Link Connection Identifier(s), and/or Internet Protocol) to provision *QWEST DSL HOST* Service using Company ATM Service.
3. The customer may request a design change to the service ordered. A design change is any change which requires engineering review. Design changes do not include a change of customer premises, end user premises or *QWEST DSL HOST* Access Link speeds. Changes of this nature will require the issuance of a new order and a cancellation of the original order. Cancellation charges are set forth in 5.2.3, preceding. Changes in *QWEST DSL* Service and *QWEST IDSL* which result in the service(s) pointing to a different *QWEST DSL HOST* Access Link are design changes and subject to the Design Change charge as set forth in 5.2.2, preceding. Changes requested on the Plant Test Date (PTD) or later will require the issuance of a new order.
4. Changes in *QWEST DSL* Service and *QWEST IDSL* Service speeds will result in a Speed Change Charge as set forth in 8.4.5.A., following.

D. Installation Guarantee *QWEST DSL PRO* (T)

In the event network difficulties develop during the installation of *QWEST DSL PRO* offerings, the Company guarantees resolution within five business days. Inability to resolve the problem within five business days will afford the customer a credit for one month of recurring charges. The credit will appear on the customer's next month's bill.

E. Service Guarantee *QWEST DSL PRO* (T)

1. Satisfaction Assurance

The Company is committed to providing the customer with a satisfactory experience when subscribing to the *QWEST DSL PRO* offerings. If the customer cancels service within 30 days after installation due to dissatisfaction, the Company will refund any recurring and nonrecurring charges accrued and waive Termination Liability.

2. Service Assurance

In the event the *QWEST DSL PRO* offerings are out of service 3 times in a 30 day period and the trouble is found to be in the customer's line, the customer may request to cancel service without having to pay any Termination Liability. This Service Assurance is not inclusive of service issues associated with the customer's modem or Internet Service Provider.

3. Line Connect Speed Assurance

*QWEST DSL PRO* offerings are designed to deliver the line speed ordered by the subscriber. However, if the *QWEST DSL PRO* line connection speed cannot be maintained to the customer's satisfaction, the Company will at the customer's request, change the customer's speed to a lower speed without assessing the Speed/Destination Channel Change Charge.
