With this filing, Verizon is correcting certain Verizon Optical Networking (VON) Price Band Rates in Section 30 of Tariff F.C.C. No. 11. These rates were originally filed under Transmittal No. 469 on July 9, 2004, and subsequently corrected under Transmittal No. 494 on September 24, 2004. The Section 30 Price Band Rates were supposed to mirror the corresponding Price Cap Rates in Section 31 of Tariff F.C.C. No. 11. This filing corrects two rates that still incorrectly did not mirror the Section 31 Price Cap Rates. This filing also provides corrections for certain VON USOCs in Tariff F.C.C. Nos. 1 and 11.

Support material as required under Section 61.49 of the Commissions' Rules is not required with this filing.
