This filing is being made on one day's notice and introduces Contract No. 04-001 for all special access services offered in Section 22 of Sprint LTC's Tariff F.C.C. No. 3. This contract provides monthly recurring credits for customers meeting certain terms and conditions specified in the contract tariff. This offering is available to qualifying customers in Sprint LTC Metropolitan Statistical Areas (MSAs) where Phase II pricing flexibility has been granted in accordance with subpart H of the Commission's Part 69 rules.

Support material as specified under Section 61.49 and 61.55 of the Commissions Rules is not required with this filing. However, description and justification introducing this contract offering is included.


