(C) Design Change Charges (Cont.)

service date is required. If the customer authorizes the Telephone Company to proceed with the design change, a Design Change Charge will apply in addition to the charge for Additional Engineering as set forth in 13.1.1 of NATIONAL EXCHANGE CARRIER ASSOCIATION TARIFF F.C.C. NO. 5. If a change of service date is required, the Service Date Change Charge as set forth in (A) preceding will also apply.

The Design Change Charge will apply on a per order, per occurrence basis, for each order requiring a design change. The applicable charge is set forth in Section 17.3.1(E).

(D) Expedited Order Charge and Expedited Circuit Charge

(C)

A customer may request a service date that is prior to the applicable service date. The request for an earlier service date may occur prior to the issuance of an order or after the order has been issued but prior to the service date. To qualify for an expedited interval the customer must provide End User premise access, where needed, until 11:00 PM (CT), Monday-Friday.

If, upon reviewing availability of equipment, facilities, and scheduled workload, the Telephone Company agrees to provide service on an expedited basis and the customer accepts this proposal, an

(D) Expedited Order Charge (Cont'd)

Expedite Order Charge (for Analog, DS0, DS1 Entrance Facilities and DS1 Access Service) or Expedite Circuit Charge (for DS3 Entrance Facilities and DS3 Access Services) will apply.

The maximum number of circuits, which may be expedited, is limited to twelve (12) two-point or six (6) multi-point Analog/DS0) circuits at the same location; a limit of four(4) DS1 circuits at the same location; and a limit of one (1) DS3 circuit at the same location.

If the Telephone Company determines that service can be provided on an expedited basis, the charges will apply based upon the agreed expedited service interval. The Expedited Order Charge applies on a per order basis regardless of the number of circuits ordered. The Expedited Circuit Charge (in case of DS3 Entrance Facilities and DS3 Access Service) applies on a per circuit basis. The applicable charges are set forth in Section 17.3.1, Access Ordering. The following table identifies the service intervals, by type of circuit.

(D) Expedited Order Charge (Cont'd)

The following also applies:

- ? In addition to Expedited Order Charges or Expedited Circuit Charges, special construction charges may apply, if the Telephone Company determines that additional costs will be incurred.
- ? When the request for expediting occurs subsequent to the issuance of the Access Order, A Service Date Change Charge as specified in paragraph (A), preceding, also applies.
- ? If the Telephone Company is subsequently unable to meet an agreed upon expedited service date, no Expedite Order Charge or Expedite Circuit Charge will apply, unless the missed service date was caused by the customer.
- ? The Telephone Company will adhere to the expedite internals as specified above, except during circumstances beyond its direct control (i.e., acts of God, government requirements, etc.)

If the Telephone Company determines that the service can be provided on the requested date and that additional labor cost or extraordinary costs are required to meet the requested service date, the customer will be notified and will be provided with an estimate of the additional charges involved.
