On October 25, 2004, NBTC issued Transmittal No. 76. NBTC proposed to change its existing one year Minimum Period for OC-48 OCN Point-to-Point Service to a 3 year Minimum Period. Existing customers were to be grandfathered, effective November 9, 2004, with no change to existing terms and conditions. Transmittal No. 76 is scheduled to become effective on November 9, 2004.

With this filing, NBTC proposes to restore currently effective material and to withdraw tariff material originally filed under Transmittal No. 76 without becoming effective. NBTC wishes to withdraw Transmittal 76 without becoming effective in order review issues identified in the proposed modifications.
