With this filing, Verizon grandfathers Optional Calling Plan Option 1, Extra Savings Plan, and Option 2, Volume Savings Plan, for both residential and business customers in Tariff FCC No. 2. Verizon also grandfathers the NY – NJ Corridor Optional Calling Plan in Tariff FCC No. 12.

Customers who currently subscribe to these optional calling plans as of December 7, 2004, are not affected by this filing and may continue with service under the existing regulations set forth in the applicable tariff. Beginning with the effective date of this filing, these optional calling plans will no longer be available to new customers. Calling services for new customers will be at the IMTS rates set forth in the applicable tariff.
