3.1 Corridor Service - Schedule I (Cont'd)(F) Optional Calling Plans

Optional Calling Plans are offered by the Telephone Company within the Corridor Service Area(s) where required billing capability exists. The minimum payment period for such plans is one month.

(1) Option I ("Extra Savings Plan")

This optional calling plan offers a participating Customer the option of paying a monthly charge to obtain a cumulative total of one hour of calling time per month for Dial Station calls within the Corridor Service Area(s). Rates apply without restriction to time-of-day or day-of-week. The Customer may place as many calls from each Main Billed Account during a month as desired to accumulate the time used. The duration of a call which involves a fractional part of a minute will be rounded up to the next higher full minute. If more than one hour of cumulative calling time is used, the additional time will be totalled and rated using the additional hour rate specified in (3)(a) following. When the additional time is less than a full hour, the charge will be the proportionate fraction of the time used multiplied by the additional hourly rate.

(a) Application of Charges

This optional calling plan is charged at recurring charges only under a Residence or Business rate schedule. Recurring charges consist of a Monthly charge and an Hourly charge. The Monthly charge applies whether or not the Customer makes any calls. The Hourly charge applies to all calls in excess of the initial one hour of calling time.

Participating multiline Customers in this optional calling plan will be billed one recurring charge for all lines associated with the Main Billed Account. Hours of usage from all lines will be accumulated and billed as if the multiline Customer were a single line account.

(1) Option I ("Extra Savings Plan") (Cont'd)

(a) Application of Charges (Cont'd)

When the billing date and the date that this optional calling plan is subscribed to, changed or disconnected do not coincide, charges which are based upon monthly rates, will be adjusted to reflect the fractional part of the month service is provided. In such cases, the initial hour of calling time will also be adjusted for the fractional part of the month that service was furnished. For billing purposes each month is considered to have 30 days.

(2) Option II ("Volume Savings Plan")

This optional calling plan offers a participating Customer the option of paying a monthly charge to obtain the discount specified in (3)(b) following applied to the rates set forth in 3.1.C.7.a. preceding for all Dial Station calls made during all rate periods (Day, Evening, Night & Weekend) within the Corridor Service Area(s).

(a) Application of Charges

This optional calling plan has both recurring and non-recurring charges. The recurring charge is due monthly and applies whether or not the Customer makes any calls.

The non-recurring charge for this optional calling plan is a service order charge which is applied when this optional calling plan is initially furnished. The service order charge will not apply for orders received within 90 days after this optional calling plan becomes available within the Corridor Service Areas.

A single monthly recurring charge will apply for all lines associated with a multiline Main Billed Account. This optional calling plan, when selected by the Customer, applies to all lines associated with a Main Billing Account.

(2) Option II ("Volume Savings Plan") (Cont'd)

(a) Application of Charges (Cont'd)

All Day, Evening, and Night and Weekend rate period call charges will be totalled for the monthly billing period. That total will be discounted by the additional 15% discount specified in (3)(b) following to determine the monthly charge to the Customer.

When the date that this optional calling plan is subscribed to, changed, or discontinued does not coincide with the billing date, charges which are based upon monthly rates will be calculated to reflect the fractional part of the month service is provided. For billing purposes each month is considered to have 30 days.

When the billing date does not coincide with the date that this optional calling plan is subscribed to, changed or discontinued, the charges for all calls will be totalled for the fractional part of the month that the service was furnished. That total will be discounted by the additional discount specified in (3)(b) following to determine the charge to the customer.
