The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Sections 61.58 and 61.59 of the Commission's Rules.

On December 3, 2004, Verizon issued Transmittal No. 517, which proposed revisions to the terms and conditions associated with its Billing Name and Address (BNA) Miscellaneous Service in its Tariff F.C.C. Nos. 1 and 11. Transmittal No. 517 is scheduled to become effective on December 18, 2004. Following discussion with the Commission's staff, Verizon wishes to withdraw the tariff material filed under Transmittal No. 517 and reinstate material currently in effect.

Verizon therefore requests special permission to waive the requirements of Section 61.59 in order to make changes to material not yet in effect and to waive the requirements of Section 61.58 in order to file those changes on less than statutory notice.

This application and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
