With this transmittal, Verizon is submitting tariff pages for a rate change in the Virginia Subscriber Line Charge rates resulting from a correction to the Primary Rate Interface (PRI) ISDN demand for the 2004 annual filing. Demand was recalculated in the price cap support for both Tariff F.C.C. No. 1 and Tariff F.C.C. No. 11, Access Service, but tariffed rate level changes were only required under Tariff F.C.C. No. 1.

Support information as specified in Sections 61.49 of the Commission’s Rules is attached. The support documentation contains the necessary workpapers, as well as the Tariff Review Plan (TRP). In addition to the TRP, this filing also contains the USAC receipts workpaper, which has been updated to reflect this change in demand.
