This filing includes proposed revisions in charges for the Federal Universal Service Contribution (FUSC) reflective of the increase in the Universal Service Contribution Factor from 8.9% to 10.7% for the first quarter of 2005. Proposed First Quarter 2005 Universal Service Contribution Factor, CC Docket No. 96-45, Public Notice, DA 04-3902 (released December 13, 2004). Two issuing carriers for JSI Tariff F.C.C. No. 1 bill FUSC charges pursuant to JSI Tariff FCC No. 1: Warwick Valley Telephone Company operating and New York and New Jersey (Warwick) and Interstate Telephone Company operating in Georgia (Interstate). Warwick files pursuant to Section 61.38. Interstate files pursuant to Section 61.39. These two carriers are not members of the National Exchange Carrier Association (NECA) Common Line Pool and therefore bill common line charges and the related FUSC charges pursuant to JSI Tariff FCC No. 1. All remaining issuing carriers for JSI Tariff FCC No. 1 participate in the NECA Common Line Pool and reference NECA Tariff FCC No. 5 with respect to FUSC rates.

This filing also proposes introduction of an optional feature for Asynchronous Transfer Mode (ATM) Cell Relay Service (CRS), "Inverse Multiplexing-ATM" (IMA). Attachment 2 comprises the Description and Justification for Inverse Multiplexing-ATM. Atlantic Telephone Membership Corporation (ATMC) has requested this option to meet the needs of an ATM customer. It will be available from any issuing carrier for JSI-Tariff F.C.C. No. 1 who provides ATM-CRS service.

Pursuant to Section 61.38 of the Commission's Rules, cost support information is being furnished for the Warwick's FUSC filing in Attachment 1. Interstate does not adjust the Multiline Business End User Common Line FUSC for Centrex, therefore its FUSC filing reflects only revision to the 10.7% factor and does not reflect any cost development work.
