Qwest is filing tariff language in its Tariff F.C.C. No. 1, Section 8, Advanced Communications Networks, to introduce a promotion for *Qwest Choice DSL*, *Qwest Choice DSL Deluxe* and Stand Alone *Qwest DSL*. Under the terms of this promotion, the Nonrecurring Charge for these services is reduced to \$10.00. In addition, the Monthly Recurring Charge for customers purchasing new *Qwest Choice DSL Deluxe* or upgrading from *Qwest Choice DSL* to *Qwest Choice DSL Deluxe* is reduced to \$25.00 for the first two months of service. The Speed/Destination Channel Charge will also be waived for customers who upgrade to *Qwest Choice DSL Deluxe* or any *QWEST DSL PRO* Service. This promotion is scheduled to run from January 9, 2005 through April 19, 2005.

Qwest is extending this promotion to stimulate demand for its higher speed DSL Products. As a result of this promotion, Qwest estimates that 49,068 of the expected *QWEST Choice DSL* new orders will instead be for higher speed DSL as follows: 45,143 *QWEST Choice DSL Deluxe* and 3,925 Stand Alone *QWEST DSL*. As a result of this promotion, Qwest expects a total increase in revenue of approximately \$5,060,700 annualized.
