In Transmittal No. 105, JSI, *inter alia*, introduced a new optional feature for Asynchronous Transfer Mode (ATM) called Inverse Multiplexing-ATM (IMA). Pursuant to Special Permission No. 04-084, this filing proposes revisions, prior to having been in effect for 30 days, to the regulations filed by JSI in Transmittal No. 105 pertaining to IMA. Pursuant to Special Permission No. 04-084, the proposed effective date for the revisions filed under this transmittal is January 1, 2004 on less than fifteen days' notice. As mentioned in the Application, the revisions serve to introduce a new rate element called an "IMA Port Charge" in lieu of charging regular ATM Port Charges for the IMA port as indicated in the original regulations filed in Transmittal No. 105.
