Under authority of Special Permission No. 05-001 of the Federal Communications Commission, Verizon is submitting tariff pages that introduce a new Contract Tariff Option (Option) in its Tariff F.C.C. Nos. 1, 11, and 14. The new Option is being filed in those Access Service tariffs where Verizon has received Pricing Flexibility relief for Special Access Services in qualifying Metropolitan Statistical Areas. This Option provides a customer with a one-time billing credit when the customer achieves certain amounts of total billed revenue for qualifying services during the service period of the Option.

Supporting material as specified under Sections 61.49 of the Commissions Rules is not required with this filing. However, a document is attached that describes in detail the tariff revisions included in this transmittal.
