
This filing is being made on not less than one day's notice under authority of Special Permission No. 05-011 of the Federal Communications Commission. Sprint LTC proposes to withdraw the tariff language and rate adjustments, originally filed February 14, 2005, under Transmittal No. 252, prior to the scheduled effective date and reinstate the existing tariff language and rates.
