With this transmittal, Verizon is introducing a new Transitional Billed Upgrade option for customers who upgrade one or two Dedicated SONET Rings into a single Dedicated SONET Ring of a greater capacity (e.g., upgrading two OC12 rings into a single OC48 ring).
