The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Section 61.58 and 61.59 of the Commission's Rules.

On March 2, 2005, Verizon filed Transmittal No. 545, which is scheduled to become effective March 17, 2005. Transmittal No. 545 introduced a new Transitional Billed Upgrade option for customers who upgrade one or two Dedicated SONET Rings into a single Dedicated SONET Ring of a greater capacity (e.g., upgrading two OC12 rings into a single OC48 ring) under its Tariff F.C.C. Nos. 1, 11, and 16, Access Services, and Tariff F.C.C. No. 14, Facilities for Interstate Access. Pursuant to discussions with the Commission's Staff, Verizon has decided to withdraw the proposed tariff option and reinstate the regulations for Verizon's Dedicated SONET Ring that are currently in effect.

A waiver of Section 61.58 is requested to allow the proposed withdrawal to become effective on less than statutory notice. A waiver of Section 61.59 is requested to allow changes to pending material not yet in effect.

This application and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).

Payment in the amount of \$720.00 has been electronically transmitted to the Mellon Bank in Pittsburgh, Pennsylvania, in accordance with the fee program procedures. The Form 159 is being transmitted electronically via ETFS.
