The accompanying tariff material, issued by Citizens Telecommunications Companies ("Citizens") and scheduled to become effective April 1, 2005, is sent to you for filing in compliance with the Communications Act of 1934, as amended. Demand and costs for all of Citizens' exchanges, including the ones subject to the current request, were included in the cost study filed under Transmittal No. 149. Citizens' demand and cost for Local Number Portability included in the cost study filed under Transmittal No. 149 have not changed since that filing and still remain applicable. With this filing, Citizens adds additional exchanges where Local Number Portability (LNP) is now available so that Citizens may recover the LNP investment and expenses and increases its USF Recovery Charge rate.
