Qwest is filing tariff language in its Tariff F.C.C. No. 1, Section 8, Advanced Communications Networks, to introduce a promotion for *Qwest Choice DSL*, *Qwest Choice DSL Deluxe* and Stand Alone *Qwest DSL*. Under the terms of this promotion, the Nonrecurring Charge for these services will be waived. In addition, the Monthly Recurring Charge for customers purchasing new *Qwest Choice DSL Deluxe* or upgrading from *Qwest Choice DSL* to *Qwest Choice DSL Deluxe* is reduced to \$19.99 for the first two months of service. The Speed/Destination Channel Charge will also be waived for customers who upgrade to *Qwest Choice DSL Deluxe*. This promotion is scheduled to run from April 10, 2005 through July 9, 2005.

Qwest is offering this promotion to stimulate demand for its DSL Products. As a result of this promotion, Qwest estimates the following demand impacts: 9,146 *Qwest Choice DSL*; 8,562 *Qwest Choice DSL Deluxe* and 5,838 Stand Alone *Qwest DSL*. As a result of this promotion, Qwest expects a total increase in revenue of approximately \$4,695,900 annualized.

In addition, Qwest is also adding language to the tariff that would waive the Speed/Destination Channel Change Charge for end users when a *QWEST DSL HOST* provider exists the marketplace. This change is being made so that end users will not be penalized when they are forced to change their DSL Host location through no fault of their own.

Supporting information discussed under Sections 61.38 and 61.49 of the Commission's Rules is, to the extent required, included in this transmittal letter.
