(H) Rates Applicable for Hearing or Speech Impaired Persons (Cont'd)

- (2) Certification - The written certification of the speech or hearing impairment must be presented to the Telephone Company's Business/Residence Service Center which serves the residence of the certified person.

The Telephone Company's Business/Residence Service Center, upon request, will provide a certification form for use by the applicant.

- (3) Limitations - The adjustment is provided for use only by the speech or hearing impaired Customer. It is only applicable to IILDMS charges for calls originated from and billed to the Exchange Service number of the residence of the certified speech or hearing impaired person. Only one Exchange Service number at a residence is authorized this rate adjustment.
