During the promotion period, when a customer orders BellSouth ADSL Service 3.0Mbps x 384Kbps as detailed in 23.5.2.21, either as new service or as an upgrade from existing BellSouth ADSL Service provided at a lower speed, a service credit of ten dollars (\$10.00) will be applied to the customer's account for each of the next three (3) months or for each month the ordered service remains in place, if the ordered service is in place less than three (3) months. All nonrecurring charges shall be billed at the normal rate and all minimum purchase and length of service requirements still apply.

25.7.14.2 General Regulations

All nonrecurring charges shall be billed at the normal rate and all minimum purchase and length of service requirements still apply.
