Under authority of Special Permission No. 05-018 Verizon issues this filing to introduce a new contract tariff option in its Tariff F.C.C. Nos. 1 and 11. The new contract tariff option provides a customer with billing credits when it meets certain total billed revenue thresholds for qualifying services. This new option is being filed in Tariff F.C.C. Nos. 1 and 11 where Verizon has received Pricing Flexibility relief for Special Access Services in qualifying Metropolitan Statistical Areas.

Supporting material as specified under Sections 61.49 of the Commissions Rules is not required with this filing. However, a description of the new contract tariff option is attached to this filing.
