The accompanying tariff material, issued on behalf of Qwest Corporation (Qwest) FRN 0003-7467-57 (Concurring Carriers, The Malheur Home Telephone Company FRN 0003-7467-65 and El Paso County Telephone Company FRN 0004-3212-46), and bearing Tariff F.C.C. No. 1, effective as reflected on the attached tariff pages, is sent to you in compliance with the requirements of the Communications Act of 1934, as amended. Qwest is filing several changes to its Tariff F.C.C. No. 1. First, Qwest is removing tariff language under the DS1/DS3 Regional Commitment Program (RCP) that allows a customer to freeze its commitment level. This change will only impact customers who subscribe or renew a RCP after the tariff becomes effective on May 3, 2005. At this time no current customers are utilizing this option.

Second, Qwest is changing language under GeoMax to allow GeoMax Ethernet ports to connect to Ethernet Ports over SONET (EPoS). Qwest is also adding two new GeoMax ports. These two new ports will be LAN PHY Ethernet Ports, 10Gbps, Protected and Unprotected. These tariff changes are being made at the request of customers who are seeking greater functionality under GeoMax Service. Under GeoMax Service Qwest is also changing tariff language associated with apportioning monthly billing in order to clarify the language.

Third, Qwest is introducing a new *Qwest DSL Premier Service*. *Qwest DSL Premier Service* will be available with both Standard *QWEST DSL Service* and Stand Alone *Qwest DSL Service*. *Qwest DSL Premier Service* and Stand Alone *DSL Premier Service* will be available for speeds up to 5Mbps with an Up Stream Connection Speed of up to 896 kbps that will vary per customer based on the capability of the customer's line and other users on the network, and therefore a singular speed is not guaranteed. Qwest is also introducing a promotion for this new service in an effort to stimulate demand.

Fourth, Qwest is filing tariff language to allow customers to purchase 10Mbps, 20Mbps, 30 Mbps, 40 Mbps, 50 Mbps, 60 Mbps, 70 Mbps, 80 Mbps and 90 Mbps speeds under the existing 1,000 Mbps Metro Optical Ethernet (MOE) Port option. This change is being made at the request of customers who are seeking greater flexibility and increased functionality under their MOE service.

Supporting information discussed under Sections 61.38 and 61.49 of the Commission's Rules is, to the extent required, included in this transmittal letter and the attached DSL Description and Justification.

As part of this filing Qwest is also adding four new special construction cases in its Tariff F.C.C. No. 2, Special Construction. Supporting information for these cases, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justification (D&J).

The Tariff filing fee in the amount of \$720.00 is being paid by credit card through the appropriate entries in Section E of the ETFS generated Form 159.
