13.14 LNP End User Charge

The LNP End User Charge recovers the costs of implementing local number portability. The LNP End User Charge shall be assessed to each end user served with the following exceptions:

- Each PBX Trunk shall be assessed nine (9) monthly LNP End User Charges as shown in sections 17.6.10.
- Each ISDN PRI arrangement shall be assessed five (5) monthly LNP End User Charges as shown in sections 17.6.10
- Lifeline customers shall not be assessed the LNP End User Charge

The LNP End User Charge shall also be assessed to carriers that purchase Telephone Company unbundled switching ports and resellers of the Telephone Company's local service.
