This filing is being made on one day's notice and revises Contract 04-001 tariff offering for special access services provided in the metropolitan statistical areas (MSAs) where Sprint LTC has been granted Phase II pricing flexibility in accordance with subpart H of the Commission's Part 69 rules. Sprint LTC proposes to increase the monthly recurring credits from 6% to 10% for the remainder of the contract term. In addition, the Charlottesville, Virginia MSA is added as an available MSA to be eligible for credit. This MSA was inadvertently omitted from the original tariff page filed under Transmittal No. 248, dated October 29, 2004. However, credits have been applied for services qualifying in Charlottesville's MSA.

Support material as specified under Section 61.49 and 61.55 of the Commissions Rules is not required with this filing.


