With this transmittal, Verizon is submitting tariff pages to introduce a new contract tariff option in Tariff F.C.C. Nos. 1, 11, and 14. This Contract Tariff (New Connect Discount Plan H) is an offering for new, converted, and upgraded orders for IntelliLight® Dedicated SONET Ring in Tariff F.C.C. Nos. 1 and 11, and Verizon Dedicated SONET Ring service in Tariff F.C.C. No. 14.

This new option is filed pursuant to Verizon receiving Pricing Flexibility relief for Special Access Services in qualifying Metropolitan Statistical Areas (MSAs)¹.

Supporting material as specified under Sections 61.49 of the Commissions Rules is not required with this filing. However, a description of the new contract tariff option is attached to this filing.
