This interstate access service tariff filing with an issue date of June 16, 2005 consists of revised tariff pages to become effective July 1, 2005 pursuant to Part 61.39 of the Commission's rules. This filing removes one issuing carrier and adds four issuing carriers. Southwest Telephone Exchange, Inc. is removed from the Kiesling Associates LLP Tariff F.C.C. No. 1 and is entering the National Exchange Carriers Association (NECA) Tariff F.C.C. No. 5 effective July 1, 2005. Dixon Telephone Company, Farmers & Merchants Mutual Telephone Company, Farmers Telephone Company – Riceville, and Interstate 35 Telephone Company are being added to the Kiesling Associates LLP Tariff F.C.C. No. 1 and are withdrawing from the National Exchange Carriers Association (NECA) Tariff F.C.C. No. 5 effective July 1, 2005. This filing also updates the issuing carrier list and table of contents for the companies joining and leaving the tariff. In

accordance with the Commission's rules, Part 61.39(b), supporting information is not required with this filing.


In accordance with the filing requirements contained in Part 61.14(b) of the Commission's rules, the aforementioned revised tariff pages are being filed electronically.
