- A12. *Qwest Choice DSL, Qwest Choice DSL Deluxe, Qwest Choice DSL Premier, Stand Alone Qwest DSL and Stand Alone Qwest DSL Premier Promotion* – July 10, 2005 through October 8, 2005

For a limited time only, the nonrecurring charge for *Qwest Choice DSL, Qwest Choice DSL Deluxe, Qwest Choice DSL Premier, Stand Alone Qwest DSL and Stand Alone Qwest DSL Premier* will be waived for customers who apply for new service.

All customers ordering new *Qwest Choice DSL Deluxe* via www.Qwest.com will receive service at the recurring rate of \$19.99 for the first twelve months. All customers ordering new *Qwest Choice DSL Deluxe* in the states of Arizona and Nebraska will receive service at the recurring rate of \$19.99 for the first twelve months. And customers who do not order via www.Qwest.com in the states of Colorado, Idaho, Iowa, Minnesota, Montana, New Mexico, North Dakota, Oregon, South Dakota, Utah, Washington and Wyoming will receive service at the recurring rate of \$26.99 for the first twelve months. Customers ordering new *Qwest Choice DSL Premier* will receive service at the recurring rate of \$29.99 for the first twelve months.

Customers who upgrade will have their Speed/Destination Channel Charge waived and receive a discount on the first three months of service under the following conditions:

- From *Qwest Choice DSL* or *Qwest DSL 640k* to *Qwest Choice DSL Deluxe*, a 3 month rate of \$26.99
- From *Qwest Choice DSL, Qwest DSL 640k* or *Qwest Choice DSL Deluxe* to *Qwest Choice DSL Premier*, a 3 month rate of \$28.00

Customers who call to disconnect *Qwest Choice DSL Deluxe* will be offered a reduced recurring rate of \$26.99 for the next 3 months for staying connected, and customers who call to disconnect *Qwest Choice DSL Premier* will be offered a reduced recurring rate of \$29.99 for the next 3 months for staying connected. In addition, customers who call to disconnect *Qwest Choice DSL Premier* will be offered *Qwest Choice DSL Deluxe* as an alternative at a reduced recurring rate of \$26.99 for the next 3 months and will have the Speed/Destination Channel Charge waived.

Customers must apply for service from July 10, 2005 through October 8, 2005 to be eligible for the promotion, with order completion within 60 days of the order application date. When order completion is delayed due to Company reasons, the order completion date will be extended. This offering is not available with any other promotion and is not available as part of the *Qwest DSL* Volume Plans.
