The accompanying tariff material, issued by the Verizon Telephone Companies (Verizon) and bearing Tariff F.C.C. No. 1, Access Service, and Tariff F.C.C. No. 20, Communications Service, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended. This material, filed on not less than one day's notice and scheduled to become effective June 30, 2005, consists of tariff pages as indicated on the following check sheets:

On June 15, 2005, Verizon issued Transmittal No. 587, which is scheduled to become effective on 15 days' notice on June 30, 2005, and was issued to expand and clarify the circumstances under which Verizon Infospeed DSL Solution service is available. Specifically, Transmittal No. 587 proposes to clarify that Verizon will provide DSL where a Customer's End User switches its existing local exchange service from Verizon to a carrier that does not use Verizon's switching facilities and does not require a dispatch of Verizon personnel to the End User's premises. Transmittal No. 587 also expands the availability of DSL for two new scenarios where a Customer's End User (1) does not currently subscribe to local exchange service provided either by Verizon or a carrier that utilizes Verizon's loop or switching facilities, or (2) receives local exchange service from a carrier that uses Verizon's loop and switching facilities, other than a reseller of Verizon's local exchange service, provided that such carrier has agreed to make the high frequency portion of such loop available to Verizon at no charge.

Under authority of Special Permission No. 05-034 of the Federal Communications Commission, Verizon proposes to withdraw only the provision that addresses Scenario (2) described above. Additional time is necessary to complete operational readiness testing for Scenario (2), and Verizon anticipates filing a separate tariff modification to make its Verizon Infospeed DSL Solutions service available in this scenario once that testing is completed. Scenario (1) and the other provisions in Transmittal No. 587 have not been changed, altered, or modified in any way and are unaffected by this Transmittal No. 594 to withdraw Scenario (2), as described herein. Scenario (1) and the other provisions will be available on June 30, 2005, according to the terms and conditions of Verizon's Transmittal No. 587.

Support material as specified under Section 61.49 of the Commissions Rules is not required with this filing.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
