With this filing, issued under authority of Special Permission No. 05-035, Verizon submits revisions to Internet Protocol – Virtual Private Network (IP-VPN) Service regulations in Parts I and II, Section 5.12 of Tariff F.C.C. No. 20 to introduce Dedicated User to Network Interface (UNI) Port with Access Line Connections, Dedicated UNI Port Only Connections and new speeds for i-VCs. A Description providing a detailed explanation of these revisions is being provided as an attachment to this filing.

Tariff revisions related to the introduction of these new IP-VPN service components are also being submitted for Tariff F.C.C. Nos. 1, 11 and 14 to clarify that applicable Special Access services may be provided between a serving wire center of a customer designated premises and a serving wire center where connection to an advanced data service such as IP-VPN occurs. Also, in Tariff F.C.C. No. 11, regulations are also being introduced to specify situations where termination liability associated with Special Access services provided under a Service Discount Plan will be waived if the customer upgrades and/or replaces Special Access service with the new Dedicated UNIs being introduced for IP-VPN.

IP-VPN Service is an interstate special access service utilizing category 1.2 facilities, as defined in Section 36.154, and is not a “loop-based” service per the definition in paragraph 61.3(yy) of the Commission’s Rules. Therefore, pursuant to paragraph 61.49(f)(3), these revisions are being filed without cost support.

Payment in the amount of \$720.00 has been electronically transmitted to the Mellon Bank in Pittsburgh, Pennsylvania, in accordance with the fee program procedures. The Form 159 is being transmitted electronically via ETFS.
