The accompanying tariff material, issued by the Consolidated Communications Companies (CCC; FRN #0010-1553-98), consisting of Consolidated Communications of Texas Company d/b/a Consolidated Communications (CCTX) and Consolidated Communications of Fort Bend Company d/b/a Consolidated Communications (CCFB), and bearing Tariff F.C.C. No. 1, Access Service, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended. The proposed effective date of July 30, 2005, is fifteen days after the filing date, in accordance with Section 204(a)(3) of the Communications Act of 1934, as amended.

This filing institutes an ADSL promotion to increase the broadband penetration within the Company's service areas. During this promotion, the rate for ADSL service will be reduced by \$10.00 to \$12.00 per month. The customers will be required to sign up for a 12-month commitment period to receive the promotional rate. Early termination will result in the customer being billed for the difference between the regular ADSL rate and the promotional rate times the months in service.

This promotional rate remains above the LRIC filed by the Company in its original ADSL tariff.


