Qwest is filing tariff language in its Tariff F.C.C. No. 1, Section 8, Advanced Communications Networks, to revise its existing promotion for *Qwest Choice DSL*, *Qwest Choice DSL Deluxe*, *Qwest Choice DSL Premier*, Stand Alone *Qwest DSL* and Stand Alone *Qwest DSL Premier*. Qwest will now offer *Qwest Choice DSL Deluxe* customers in the states of Arizona and Nebraska who call and wish to disconnect, a twelve month reduction of their Monthly Recurring Charge to \$19.99. *Qwest Choice DSL Deluxe* customers in the states of Colorado, Idaho, Iowa, Minnesota, Montana, New Mexico, North Dakota, Oregon, South Dakota, Utah, Washington and Wyoming who call and wish to disconnect will receive a twelve month reduction of their Monthly Recurring Charge to \$26.99.

Qwest Choice DSL Premier Customers who call and wish to disconnect will now be offered, a twelve month reduction of their Monthly Recurring Charge to \$29.99. In addition, *Qwest Choice DSL Premier* customers in the states of Arizona and Nebraska who call and wish to disconnect will be offered *Qwest Choice DSL Deluxe* at \$19.99 for twelve months and will have the Speed/Destination Channel Charge waived. *Qwest Choice DSL Premier* customers in the states of Colorado, Idaho, Iowa, Minnesota, Montana, New Mexico, North Dakota, Oregon, South Dakota, Utah, Washington and Wyoming who call and wish to disconnect will be offered *Qwest Choice DSL Deluxe* at \$26.99 for twelve months and will have the Speed/Destination Channel Charge waived.

These revised promotional terms will not be available to *QWEST DSL Volume Plan* Customers and are scheduled to run from August 9, 2005 through October 8, 2005.

Qwest is revising this promotion in response to concerns expressed by current customers who wish to have the new promotional terms also available to them. This change is not projected to change the previous promotional estimates. These were as follows, Qwest estimates the following demand impacts: 8,288 *QWEST Choice DSL*; 14,245 *QWEST Choice DSL Deluxe*, 2,590 *Qwest Choice DSL Premier*, 518 Stand Alone *Qwest DSL* and 259 Stand Alone *Qwest DSL Premier*. As a result of this promotion, Qwest expects a total increase in revenue of approximately \$5,165,490 annualized.

Supporting information discussed under Sections 61.38 and 61.49 of the Commission's Rules is, to the extent required, included in this transmittal letter.
