With this filing, Verizon is proposing rate reductions for the 768/128K speed Verizon Infospeed Digital Subscriber Line (DSL) service and the 768/128K speed DSL Over Resold Lines (DRL) service. The rate reductions will further Verizon’s ability to compete effectively and promote broadband penetration. They reflect the greater certainty in the regulatory environment in the wake of the Commission’s recent adoption on August 5, 2005 of an order eliminating mandated sharing requirements on incumbents’ wireline broadband Internet access services.

Supporting material as described under Section 61.49 is included for the Tariff F.C.C. No. 1 portion of the filing.
