These revisions, scheduled to become effective September 3, 2005 consist of tariff pages as indicated on the following check sheets:

This filing is being made on 15 days' notice under the Federal Communications Commission's streamlined filing procedures, and proposes the following revisions to Tariff F.C.C. No. 3:

- 1) Addition of three and five year rates for frame relay user-to-network interface (UNI) port and month-to-month, three and five year rates for network-to-network interface (NNI) port at 384 kbps level and a permanent virtual circuit with a committed information rate of 192 kbps in the state of Nevada;
- 2) Addition of rates to provide diverse route facilities in order to meet the specific requirement of customers in the states of Indiana and Kansas;
- 3) Addition of special construction charges for the installation of fiber optic cable in order to meet the specific requirements of customers in the states of Florida, Missouri, Nebraska, North Carolina and Ohio;

- 4) Addition of a promotional offering waiving the nonrecurring charges when a customer installs a new Sprint Custom Access SolutionsSM arrangement under a three year minimum service period from September 3, 2005 through December 31, 2005; and
- 5) Minor tariff language changes designed to clarify the provision of interstate access services.


Cost support material in accordance with Sections 61.38 and 61.41 through 61.49 of the Commission's Rules is provided, where required, for this filing.
