The accompanying tariff material, issued on behalf of Qwest Corporation (Qwest) FRN 0003-7467-57 (Concurring Carriers, The Malheur Home Telephone Company FRN 0003-7467-65 and El Paso County Telephone Company FRN 0004-3212-46), and bearing Tariff F.C.C. No. 1, effective as reflected on the attached tariff pages, is sent to you in compliance with the requirements of the Communications Act of 1934, as amended. Tariff material, issued on behalf of Qwest Corporation (Qwest) FRN 0003-7467-57 (Concurring Carrier, The Malheur Home Telephone Company FRN 0003-7467-65), and bearing Tariff F.C.C. Qwest is filing tariff language in its Tariff F.C.C. No. 1, Section 8, Advanced Communications Networks, to introduce a promotion for *Qwest Choice DSL*, *Qwest Choice DSL Deluxe*, *Qwest Choice DSL Premier*, Stand Alone *Qwest DSL* and Stand Alone *Qwest DSL Premier*. Under the terms of this promotion, the Nonrecurring Charge for these services will be waived. In addition, the Monthly Recurring Charge for customers purchasing new *Qwest Choice DSL Deluxe* via www.Qwest.com or in the states of Arizona and Nebraska will be reduced to \$19.99 for the first twelve months. Other new *Qwest Choice DSL Deluxe* customers who do not meet these criteria will have their Monthly Recurring Charge reduced to \$26.99 for the first twelve months. And Customers ordering new *Qwest Choice DSL Premier* will receive service at the recurring rate of \$29.99 for the first twelve months.

Customers who upgrade from *Qwest Choice DSL* or *Qwest DSL 640k* to *Qwest Choice DSL Deluxe* will have their Speed/Destination Channel Charge waived and the recurring rate reduced to \$26.99 for the first three months of service. Customers who upgrade from *Qwest Choice DSL*, *Qwest DSL 640k* or *Qwest Choice DSL Deluxe* to *Qwest Choice DSL Premier* will have their Speed/Destination Channel Charge waived and the recurring rate reduced to \$28.00. The Speed/Destination Channel Charge will also be waived for customers who change from DSL Stand Alone Service to DSL Standard Service within their current speed or upgrade to *Qwest DSL Premier* Service. In addition customers who upgrade from Stand Alone *QWEST DSL* Service to Stand Alone *Qwest DSL Premier* Service will have their Speed/Destination Channel Charge waived.

Customers who call to disconnect *Qwest Choice DSL Deluxe* in the states of Arizona and Nebraska will be offered a reduced recurring rate of \$19.99 for the next twelve months for staying connected. Customers who call to disconnect *Qwest Choice DSL Deluxe* in the states of Colorado, Idaho, Iowa, Minnesota, Montana, New Mexico, North Dakota, Oregon, South Dakota, Utah, Washington and Wyoming will be offered a reduced recurring rate of \$26.99 for the next twelve months for staying connected. And customers who call to disconnect *Qwest Choice DSL Premier* will be offered a reduced recurring rate of \$29.99 for the next twelve months for staying connected.

In addition, customers who call to disconnect *Qwest Choice DSL Premier* in the states of Arizona and Nebraska will be offered *Qwest Choice DSL Deluxe* as an alternative at a reduced recurring rate of \$19.99 for the next twelve months and will have the Speed/Destination Channel Charge waived. Customers who call to disconnect *Qwest Choice DSL Premier* in the states of Colorado, Idaho, Iowa, Minnesota, Montana, New Mexico, North Dakota, Oregon, South Dakota, Utah, Washington and Wyoming will be offered *Qwest Choice DSL Deluxe* as an alternative at a reduced recurring rate of \$26.99 for the next twelve months and will have the Speed/Destination Channel Charge waived.

This promotion is scheduled to run from October 9, 2005 through January 28, 2006.

Qwest is offering this promotion to stimulate demand for its DSL Products and retain existing customers. As a result of this promotion, Qwest estimates the following demand impacts: 3,502 *QWEST Choice DSL*; 11,869 *QWEST Choice DSL Deluxe*, 3,308 *Qwest Choice DSL Premier*, 389 Stand Alone *Qwest DSL* and 389 Stand Alone *Qwest DSL Premier*. As a result of this promotion, Qwest expects a total increase in revenue of approximately \$5,688,000 annualized.

Qwest is also filing tariff language in Section 8 to introduce a promotion for ATM, Local Area Network (LAN) Switching Service (LSS) and Frame Relay Service (FRS). Under the terms of this promotion, Qwest will waive the nonrecurring charges for customers who purchase ATM, FRS and LSS with term plans of 36-months or greater. This promotion will be in effect from October 8, 2005 through November 30, 2005.

Qwest is offering this promotion to stimulate demand. As a result of this promotion Qwest estimates that demand for these Services will increase as follows: 15 ATM Services, 688 Frame Relay Services and 1 LSS Services. Qwest expects a total increase in revenue of approximately \$2,570,000 for the first twelve months.

As part of this filing Qwest is also filing tariff language in Section 2, General Regulations, to allow Switched Access Service on a Self-Healing Network Service (SHNS) Shared Use facility and on GeoMax Service Shared Use facility. This tariff change is being made at the request of customers seeking greater flexibility in association with these services.

Qwest is also making one other minor change which involves withdrawing an optional program from Section 6, Switched Access Service. Qwest is withdrawing the optional Switched Transport Commitment Program due to lack of demand. There are currently no customers participating in this program.

Supporting information discussed under Sections 61.38 and 61.49 of the Commission's Rules is, to the extent required, included in this transmittal letter.

As part of this filing Qwest is also adding one new special construction case in its Tariff F.C.C. No. 2, Special Construction. Supporting information for this case, discussed under Section 61.38 of the Commission's Rules, is included in the attached Special Construction Description and Justification (D&J).

The Tariff filing fee in the amount of \$720.00 is being paid by credit card through the appropriate entries in Section E of the ETFS generated Form 159.
