With this filing, Verizon is proposing reductions in the Exchange Access Frame Relay Service Rate Stability Plan rates in Tariff FCC Nos. 1 and 20. The rate reductions will benefit both new and existing Rate Stability Plan customers. Also, Rate Stability Plan USOCs are being added in Tariff FCC No. 20.

Supporting material as required under Section 61.49 for a rate change is included for the Tariff F.C.C. No. 1 portion of the filing. Exchange Access Frame Relay Service is an interstate special access service utilizing category 1.2 facilities, as defined in Section 36.154, and is not a "loop-based" service per the definition in paragraph 61.3(yy) of the Commission's Rules. Therefore, pursuant to paragraph 61.49(f)(3), the Tariff F.C.C. No. 20 rate change portion of the filing is being filed without cost support.

Payment in the amount of \$720.00 has been electronically transmitted to the Mellon Bank in Pittsburgh, Pennsylvania, in accordance with the fee program procedures. The Form 159 is being transmitted electronically via ETFS.
